On March 16, 2020 we were notified by the State of New York that our operations were to be closed until further notice due to the COVID-19 health pandemic that was effecting our nation and the world.

Who knew that this closure would last almost six months before we could reopen with limited occupancy, and a whole list of new guidelines and operating procedures mandated by the State.

Our Norwich YMCA has been in operations since 1862 and there has been no time in our history where we were closed for operations for as long as we experienced in 2020. Although our building was closed to our membership, we were still operating in a crisis mode, providing essential childcare to emergency and essential employees required to work and we continued to assist our community in other ways such as community food programs, a shepherding program for seniors, and more.

This was a difficult time for our organization. Our building was closed and our two main sources of income: membership and program revenue were basically put on hold, while our expenses still remained: heat, electricity, equipment leases, insurance, etc.

We partnered with other YMCA's in New York State with an online social media support campaign entitled "Open for Good" to help YMCA's across the state during this time. During this time, Norwich YMCA members and community friends supported this initiative to help us during this most challenging time in our history.

We are most appreciative of the following donors that participated in the "Open for Good" statewide campaign. Your direct support financially supported the Norwich YMCA with over \$8,070.09 in donations that directly impacted and supported our operations.
